PAPER REGISTRATIONS

Registrations will not be accepted by telephone!

DEADLINES:

Payment must be post-marked by the following dates in order to take advantage of the special registration fees:

Early Bird Registration Fee - by August 1, 2010

Regular Registration Fee - August 1, 2010 - September 3, 2010

On-Site Registration Fee - after September 3, 2010

What a registration fee includes?

A full registration includes all education sessions, committee meetings, the Grand Opening Cocktail Party, Thursday Lunch on the Go, Thursday Happy Hour, Thursday Night Party, Friday Brunch and the Continental Breakfast on Saturday.

What a registration fee does NOT include?
