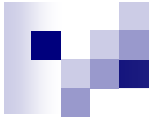

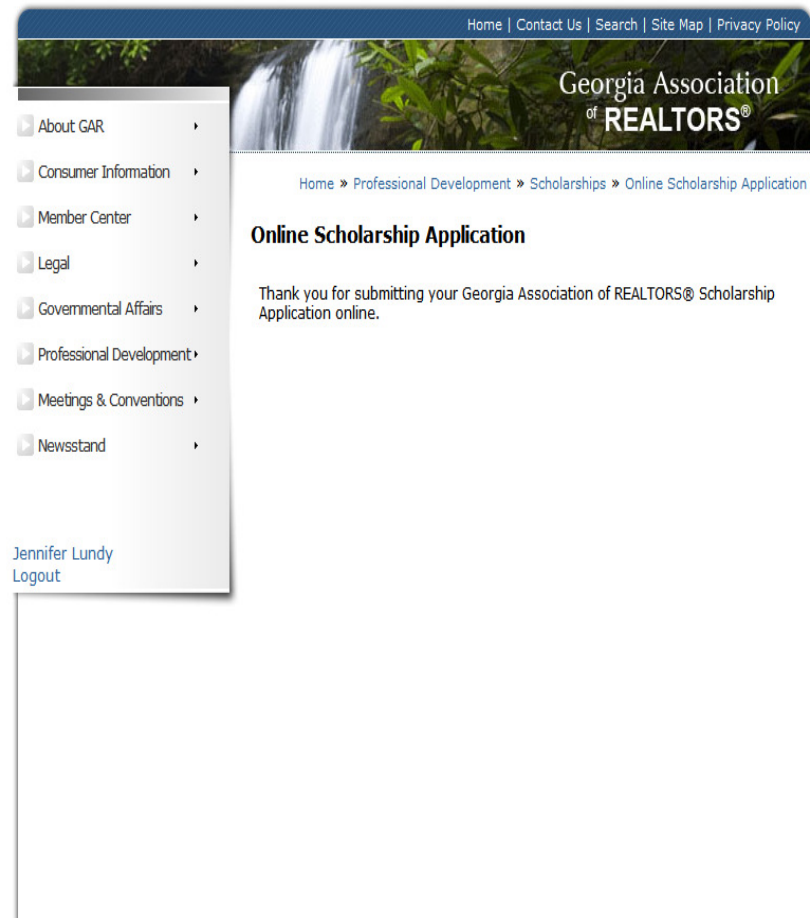

 - Review process occurs during 3rd week following the end of a quarter
 - Checks are typically cut the week after approval
 - Please allow 4-6 weeks following quarter to receive check
